What to do if you have a welfare concern

Why are you concerned?

For example:

Something a child has said, for example, an allegation of harm

Child's appearance; may include frequent or unexplained injuries/ marks/bruises and/or dress

Behaviour change(s)

Witnessed concerning, harmful or inappropriate behaviour

Act immediately and record your concerns: If urgent, speak to a DSL first

Follow the school procedure (all concerns to be logged via Classcharts and directly to a DSL) Reassure the child

Clarify any concerns using open questions, if necessary (TED: Tell, Explain, Describe)

Record facts and not opinions, and use child's own words.

Seek support for yourself as required from DSL

Inform the Federation Designated Safeguarding Lead (Hannah Ferris, spd@lightyear.kent.sch.uk)

If a child is at risk of immediate harm and/or is unsafe to go home, make an urgent Request for Support to the Front Door Service via the portal or call the Police on 999.

If no immediate risk of harm, provide internal support and/or refer to other agencies in line with Kent Safeguarding Support Level Guidance and KSCMP procedures, as appropriate. For example, signposting to community services and/or early help open access, a non-urgent call to the Police via 101, reporting allegations against staff to the County LADO Service, or make a Request for Support via the Front Door Service Portal.

If the school/college believes a child may be in need of support but are unclear whether to refer, a no-named consultation can be sought from the Front Door Service via 03000 411 111 If support is required out of working hours, the school/college will contact the Out of Hours Service via 03000 41 91 91.

If you are unhappy with the response:

DSLs/Staff:

Follow Federation whistleblowing procedures (available via school website)

Follow Kent safeguarding partnership escalation procedures.

Children or Parents:

Follow Federation complaints procedures (available via school website)

Record decision making and action taken in the child's safeguarding file

Monitor

Be clear about:

What you are monitoring, for example, behaviour trends, appearance. How long you will monitor

Where, how and to whom you will feedback, and how you will record

Review and **request further support** if necessary.

At all stages, the child's circumstances will be kept under review The DSL/staff will request further support if required to ensure the **child's safety** is paramount

1. Child Focused Approach to Safeguarding

1.1 Introduction

- The Lightyear Federation recognises our statutory responsibility to safeguard and promote the welfare
 of all children. Safeguarding and promoting the welfare of children is <u>everybody's</u> responsibility and
 everyone has a role to play. All members of our community (staff, volunteers, governors, leaders,
 parents/carers, wider family networks, and learners) have an important role in safeguarding children
 and all have an essential role to play in making our community safe and secure.
- The Lightyear Federation believes that the best interests of children always come first. All children (defined in law and in this policy as those up to the age of 18) have a right to be heard and all children regardless of age, sex (gender), ability, culture, race, language, religion or sexual identity or orientation, have equal rights to protection.
- Staff working with children within The Lightyear Federation will maintain an attitude of 'it could happen here' where safeguarding is concerned. When concerned about the welfare of a child, staff will always act in the best interests of the child and if any member of our community has a safeguarding concern about any child or adult, they should act and act immediately.
- This policy applies where there are any child protection concerns regarding children who attend our schools or nursery, but may also apply to other children connected to The Lightyear Federation, for example, siblings, younger members of staff (under 18s) or children on student/work placements.
- The Lightyear Federation recognises the importance of providing an ethos and environment within our schools that will help children to be safe and to feel safe, and where children can enjoy learning and grow in confidence. In our schools and nursery setting, children are respected and are encouraged to talk openly. We will provide age-appropriate educational opportunities to enable children to develop positive relationships, self-regulation, social and emotional understanding, communication, language to help them understand how to keep themselves safe. We will ensure children's wishes and feelings are taken into account when determining what safeguarding action to take and what services to provide.
- The Lightyear Federation recognises that we play an essential role in helping children to understand and identify the parameters of what is appropriate child and adult behaviour; what is 'safe'; to recognise when they and others close to them are not safe; and how to speak to trusted adults who can support them when they are concerned. Children in our school and nursery settings will be listened to and heard and their concerns will be taken seriously and acted upon as appropriate.
- The Lightyear Federation recognises the importance of adopting a trauma informed approach to safeguarding, considering the root causes and possible underlying trauma behind children's behaviour.
- Our core safeguarding principles are:
 - Prevention: positive, supportive, safe culture, curriculum and pastoral opportunities for children and safer recruitment procedures. Our schools apply the nurture principles to ensure that children feel safe in the environment to talk to others.
 - o **Protection**: following the agreed procedures, ensuring all staff are trained and supported to recognise and respond appropriately and sensitively to safeguarding concerns.
 - Support: adopt a child centred approach and provide support for all learners, parents/carers and staff, and where appropriate, implement specific interventions are required for those who may be at risk of harm.

- o **Collaborating**: with both parents where possible, and other agencies to ensure timely, appropriate communications and actions are undertaken when safeguarding concerns arise.
- The procedures contained in this policy apply to all staff, including governors, temporary or third-party agency staff and volunteers, and are consistent with those outlined within 'Keeping Children Safe in Education' 2025.
- The Lightyear Federation adheres to the Kent Safeguarding Children Multi-Agency Partnership (KSCMP) safeguarding children's procedures. The full KCSMP procedures, documents and additional guidance relating to specific safeguarding issues can be found on the KCSMP website.

1.2 Policy context

- This policy is implemented in accordance with our compliance with the current statutory guidance from the Department for Education, 'Keeping Children Safe in Education' (KCSIE) which requires individual schools to have an effective child protection policy and the Department for Education EYFS Guidance.
- This policy has been developed in accordance with the principles established by the Children Acts 1989 and 2004 and related national and local guidance. This includes but is not limited to:
 - Keeping Children Safe in Education (KCSIE)
 - Working Together to Safeguard Children (WTSC)
 - Early Years and Foundation Stage Framework (EYFS)
 - Ofsted: Education Inspection Framework'
 - Framework for the Assessment of Children in Need and their Families 2000
 - o Kent and Medway Safeguarding Children Procedures
 - Early Years and Foundation Stage Framework (EYFS)
 - The Education Act 2002
 - Education and Inspections Act 2006
 - The Human Rights Act 1998
 - The Equality Act 2010 (including the Public Sector Equality Duty)
- Section 175 of the Education Act 2002 requires school governing bodies, local education authorities
 and further education institutions to make arrangements to safeguard and promote the welfare of all
 children who are pupils at a school, or who are students under 18 years of age. Such arrangements
 will have to have regard to any guidance issued by the Secretary of State.
- The Lightyear Federation will follow local or national guidance in response to any emergencies. We
 will amend this policy and our procedures as necessary but regardless of the action required, our
 safeguarding principles will always remain the same; the welfare of the child is paramount.

1.3 Definition of safeguarding

- In line with 'Working Together to Safeguard Children' and KCSIE, safeguarding and promoting the welfare of children is defined for the purposes of this policy as:
 - providing help and support to meet the needs of children as soon as problems emerge
 - o protecting children from maltreatment, whether that is within or outside the home, including online
 - o preventing impairment of children's mental and physical health or development
 - ensuring that children grow up in circumstances consistent with the provision of safe and effective care
 - o promoting the upbringing of children with their birth parents, or otherwise their family network whenever possible and where this is in the best interests of the child(ren)
 - o taking action to enable all children to have the best outcomes.

- Child protection is part of safeguarding and promoting the welfare of all children and is defined as
 activity that is undertaken to protect specific children who are suspected to be suffering, or likely to
 suffer, significant harm. This includes harm that occurs inside or outside the home, including
 online.
- The Lightyear Federation acknowledges that safeguarding includes a wide range of specific issues including (but not limited to):
 - Abuse and neglect
 - o Bullying, including cyberbullying
 - o Child-on-child abuse
 - Children with family members in prison
 - Children who are absent of missing from education (CME)
 - Child missing from home or care
 - Child Sexual Exploitation (CSE)
 - Child Criminal Exploitation (CCE)
 - Contextual safeguarding (risks outside the family home)
 - County lines and gangs
 - o Domestic abuse
 - o Drugs and alcohol misuse
 - Fabricated or induced illness
 - Faith abuse
 - Gender based abuse and violence against women and girls
 - Hate
 - Homelessness
 - Human trafficking and modern slavery
 - Mental health
 - Nude or semi-nude image sharing, also known as youth produced/involved sexual imagery or "Sexting"
 - Online safety
 - Preventing radicalisation and extremism
 - Private fostering
 - Relationship abuse
 - o Serious violence
 - Sexual violence and sexual harassment
 - So-called 'honour-based' abuse, including Female Genital Mutilation (FGM) and forced marriage
 - o 'Upskirting'

1.5 Policy compliance, monitoring and review

- The Lightyear Federation will review this policy at least annually (as a minimum) and will update it as needed, so that it is kept up to date with safeguarding issues as they emerge and evolve, including lessons learnt. The policy will also be revised following any national or local updates, significant local or national safeguarding events and/or learning, and/or any changes to our own procedures.
- All staff (including temporary staff and volunteers) will be provided with a copy of this policy and Part
 One and/or Annex A of KCSIE as appropriate. Copies will be available in the safeguarding folder in
 the staff room.
- Parents/carers can obtain a copy of our Safeguarding and Child Protection Policy and other related policies on request. Additionally, our policies can be viewed via om the 'policy' pages on our school/nursery websites:

- This policy forms part of our federation development plans and will be reviewed annually by the Governing body who has responsibility for oversight of safeguarding and child protection systems.
- The Designated Safeguarding Lead (DSL), Executive Headteacher and Head of School will ensure regular reporting on safeguarding activity and systems to the Governing Body. The Governing Body will not receive details of individual learner situations or identifying features of families as part of their oversight responsibility.

2 Key Responsibilities

2.1 Governance and leadership

- The Governing Body and leadership team have a strategic responsibility for our safeguarding
 arrangements and will comply with their duties under legislation. The Governing Body have regard to
 the KCSIE and EYFS guidance and will ensure our policies, procedures and training is effective and
 complies with the law at all times.
- The Governing Body will facilitate a whole federation approach to safeguarding which involves
 everyone. They will ensure that safeguarding and child protection are at the forefront and underpin all
 relevant aspects of process and policy development, so that all systems, processes, and policies
 operate with the best interests of the child at their heart.
- The Governing Body are aware of their obligations under the Human Rights Act 1998, the Equality Act 2010, (including the Public Sector Equality Duty), and the local multi-agency safeguarding arrangements set out by the Kent Safeguarding Children Multi-Agency Partnership (KSCMP).
 - This includes but is not limited to safeguarding all members of the federation community (for example, staff, learners, parents/carers and other family members) identified with protected characteristics within the Equality Act; age, disability, gender reassignment, marriage and civil partnership, pregnancy and maternity, race, religion or belief, sex, sexual orientation.
 - For further information about our approaches to equality, diversity, and inclusion, please access our Equality Plan which can be found on each school website or requested from the school office.
- The Governing Body and leadership team will ensure that there are policies and procedures in place to ensure appropriate action is taken in a timely manner to safeguard and promote children's welfare.
- The Executive Headteacher and Head of School will ensure that our child protection and safeguarding policies and procedures adopted by the Governing Body, are understood, and followed by all staff.
- The Governing Body will ensure an appropriate senior member of staff, from the school leadership team, is appointed to the role of designated safeguarding lead. The Governing Body and leadership team will ensure that the DSL is supported in their role and is provided with sufficient time so they can provide appropriate support to staff and children regarding any safeguarding and welfare concerns.
- The Lightyear Federation has three nominated governors for safeguarding. These nominated governors will support the DSL and have oversight in ensuring that each school/nursery has an effective policy which interlinks with other related policies, that locally agreed procedures are in place and being followed, and that the policies are reviewed at least annually and when required.

2.2 Designated Safeguarding Lead (DSL)

- The Lightyear Federation has appointed Hannah Ferris (Safeguarding and Pastoral Director), a member of the executive and senior leadership team, to act as our Designated Safeguarding Lead (DSL).
- The DSL has overall responsibility for the day-to-day oversight of safeguarding and child protection systems (including online safety and understanding the filtering and monitoring systems and processes in place) in our schools and nursery.
- The Lightyear Federation have also appointed Deputy DSLs who will have delegated responsibilities and act in the DSL's absence.

- Whilst the activities of the DSL may be delegated to the deputies, the ultimate lead responsibility for safeguarding and child protection remains with the DSL and this responsibility will not be delegated.
- The DSL (and any deputies) will be more likely to have a complete safeguarding picture and will be the most appropriate person to advise staff on the response to any safeguarding concerns.
- It is the role of the DSL to carry out their functions as identified in Annex C of KCISE 2022. This
 includes but is not limited to:
 - Acting as the central contact point for all staff to discuss any safeguarding concerns
 - o Maintaining a confidential recording system for safeguarding and child protection concerns
 - Coordinating safeguarding action for individual children
 - When supporting children with a social worker or looked after children, the DSL should have the details of the child's social worker and the name of the virtual school head in the authority that looks after the child, with the DSL liaising closely with the designated teacher.
 - Liaising with other agencies and professionals in line with KCSIE, EYFS and WTSC.
 - Ensuring that locally established procedures as put in place by the three safeguarding partners
 as part of the Kent Safeguarding Children Multi-Agency Partnership (KSCMP) procedures,
 including referrals, are followed, as necessary.
 - Representing, or ensure the school/nursery is appropriately represented at multi-agency safeguarding meetings (including child protection conferences)
 - o Managing and monitoring the school/nursery role in any multi-agency plan for a child.
 - Being available during term time (during school hours) for staff in the federation to discuss any safeguarding concerns.
 - Ensuring adequate and appropriate DSL cover arrangements in response to any closures and any out of hours and/or out of term activities.
 - Taking lead responsibility for online safety, including understanding the filtering and monitoring systems and processes in place.
 - Helping promote educational outcomes by sharing the information about the welfare, safeguarding and child protection issues that children, including children with a social worker, are experiencing, or have experienced, with teachers and federation leadership staff.
 - Ensuring all staff access appropriate safeguarding training and relevant updates in line with the recommendations within KCSIE and EYFS Guidance.
 - Liaising with the Executive Headteacher and Head of School to inform them of any safeguarding issues, especially ongoing enquiries under section 47 of the Children Act 1989 and police investigations. This includes being aware of the requirement for children to have an Appropriate Adult (<u>PACE Code C 2019</u>).
- The DSL will undergo appropriate and specific training to provide them with the knowledge and skills required to carry out their role. Deputy DSLs will be trained to the same standard as the DSL. The DSLs' training will be updated formally at least every two years, but their knowledge and skills will be updated through a variety of methods at regular intervals and at least annually.

2.3 Members of staff

- Our staff play a particularly important role in safeguarding as they are in a position to observe changes in a child's behaviour or appearance, identify concerns early, provide help for children, promote children's welfare and prevent concerns from escalating. Everyone involved in the care of children has a role to play in their protection.
- All members of staff have a responsibility to:
 - o take all necessary steps to keep children safe and well
 - o provide a safe environment in which children can learn.
 - ensure that adequate supervision of children is implemented in line with federation policies, including that whilst children in EYFS are eating they must be within sight and hearing of an adult
 - o be alert to any issues of concern in a child's life at home or elsewhere.
 - be aware of the indicators of abuse, neglect and exploitation so that they can identify cases of children who may need help or protection.
 - know what to do if a child tells them that they are being abused, neglected, or exploited and understand the impact this can have upon a child.
 - be able to identify and act upon indicators that children are, or at risk of, developing mental health issues.
 - be prepared to identify children who may benefit from early help and understand the early help process and their role in it.
 - o understand the school/nursery safeguarding policies and systems.
 - o undertake and engage in regular and appropriate training which is regularly updated.
 - be aware of the local process of making referrals to children's social care and statutory assessment under the Children Act 1989.
 - o know how to maintain an appropriate level of confidentiality.
 - reassure children who report concerns that they are being taken seriously and that they will be supported and kept safe.
 - o act in line with our staff code of conduct
 - act in line with the <u>Teachers' Standards</u> which state that teachers (including headteachers) should safeguard children's wellbeing and maintain public trust in the teaching profession as part of their professional duties.
 - Staff within The Lightyear Federation recognise that children may not feel ready or know how to tell someone that they are being abused, exploited, or neglected, and/or they may not recognise their experiences as being abusive or harmful. This should not prevent staff from having professional curiosity and speaking to a DSL if they have any concerns about a child.
 - Staff within The Lightyear Federation will determine how best to build trusted relationships with children and parents/carers which facilitate appropriate professional communication in line with existing and relevant policies, for example, our staff code of conduct and behaviour policies.

2.4 Children

- Children have a right to:
 - o Feel safe, be listened to, and have their wishes and feelings taken into account.
 - Confidently report abuse, neglect or exploitation, knowing their concerns will be treated seriously, and knowing they can safely express their views and give feedback.
 - Contribute to the development of federation safeguarding policies.
 - Receive help from a trusted adult.
 - Learn how to keep themselves safe, including online.

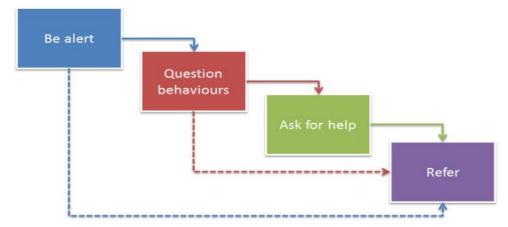
2.5 Parents and carers

- Parents/carers have a responsibility to:
 - Understand and adhere to the relevant federation policies and procedures.
 - Talk to their children about safeguarding issues and support the federation in their safeguarding approaches.
 - o Identify behaviours which could indicate that their child is at risk of harm, including online.
 - Seek help and support from the school/nursery or other agencies.

3 Child Protection Procedures

3.1 Recognising indicators of abuse, harm, neglect and exploitation

- Staff will maintain an attitude of 'it could happen here' where safeguarding is concerned. When concerned about the welfare of a child, staff will always act in the best interests of the child.
- All staff are made aware of the definitions and indicators of abuse, harm, neglect and exploitation as identified by Working Together to Safeguard Children and Keeping Children Safe in Education. This is outlined locally within the <u>Kent Support Levels Guidance</u>.
- The Lightyear Federation recognises that when assessing whether a child may be suffering actual or potential harm there are four categories of abuse (for more in-depth information, see appendix 1):
 - o Physical abuse
 - Sexual abuse
 - o Emotional abuse
 - Neglect
- By understanding the indicators of abuse, harm, neglect and exploitation, we can respond to
 problems as early as possible and provide the right support and services for the child and their family.
 - All members of staff are expected to be aware of and follow 'What to do if you are worried a child is being abused' guidance if they are concerned about a child:



'What to do if you are worried a child is being abused'

The Lightyear Federation recognises that concerns may arise in many different contexts and can
vary greatly in terms of their nature and seriousness. The indicators of child abuse, harm, neglect
and exploitation can vary from child to child. Children develop and mature at different rates, so

what appears to be worrying behaviour for a younger child might be normal for an older child. It is important to recognise that indicators of abuse, harm, neglect and exploitation do not automatically mean a child is being harmed however all concerns should be taken seriously and will be explored by the DSL on a case-by-case basis.

- The Lightyear Federation recognises abuse, harm, neglect, exploitation and other safeguarding
 issues are rarely standalone events and cannot always be covered by one definition or one label
 alone. In many cases, multiple issues will overlap with one another, therefore staff will always be
 vigilant and always raise concerns with a DSL.
- Parental behaviors can indicate child abuse, harm, neglect or exploitation; staff will be alert to
 parent-child interactions or concerning parental behaviours; this could include parents who are
 under the influence of drugs or alcohol or if there is a sudden change in their mental health.
- Children may report abuse, harm, neglect and exploitation happening to themselves, their peers or their family members. All reports made by children to staff will be taken seriously and will be responded to in line with this policy.
- Safeguarding incidents and/or behaviours can be associated with factors and risks outside of school/nursery. Children can be at risk of abuse, harm, neglect or exploitation in situations outside their families; extra-familial harms take a variety of different forms and children can be vulnerable to multiple harms including (but not limited to) sexual exploitation, criminal exploitation, sexual abuse, serious youth violence and county lines.
- The Lightyear Federation recognises that technology can be a significant component in many safeguarding and wellbeing issues; children are at risk of abuse, harm, neglect or exploitation online from people they know (including other children) and from people they do not know; in many cases, abuse will take place concurrently via online channels and in daily life.
- The Lightyear Federation recognises that some children have additional or complex needs and may require access to intensive or specialist services to support them.
- Following a concern about a child's safety or welfare, the searching and screening of children and confiscation of any items, including any electronic devices, will be managed in line with the The Lightyear Federation's behaviour policy which is informed by the DfE 'Searching, screening and confiscation at school' guidance.
 - The DSL (or deputy) will be informed of any searching incidents where there were reasonable grounds to suspect a learner was in possession of a prohibited item as listed in our behaviour policy. The DSL (or deputy) will then consider the circumstances of the learner who has been searched to assess the incident against any potential wider safeguarding concerns.
 - Staff will involve the DSL (or deputy) without delay if they believe that a search has revealed a safeguarding risk.

3.2 Responding to child protection concerns

- If staff are made aware of a child protection concern, they are expected to:
 - o listen carefully to the child, reflecting back the concern.
 - o use the child's language.
 - o be non-judgmental.
 - avoid leading questions; only prompting the child where necessary with open questions to clarify information where necessary. For example, who, what, where, when or Tell, Explain, Describe (TED).
 - o not promise confidentiality as concerns will have to be shared further, for example, with the DSL and potentially Integrated Children's Services.

- o be clear about boundaries and how the report will be progressed.
- o record the concern on ClassCharts using the facts as the child presents them, in line with our record keeping requirements.
- o inform the DSL (or deputy), as soon as practically possible.
- All staff are made aware that early information sharing is vital for the effective identification, assessment, and allocation of appropriate service provision, whether this is when problems first emerge, or where a child is already known to other agencies. Staff will not assume a colleague, or another professional will act and share information that might be critical in keeping children safe.
- The Lightyear Federation will respond to safeguarding concerns in line with the Kent Safeguarding Children Multi-Agency Partnership procedures (KSCMP).
 - The full KSCMP procedures and additional guidance relating to reporting concerns and specific safeguarding issues can be found on their website: www.kscmp.org.uk
- In Kent, Early Help and Preventative Services and Children's Social Work Services are part of <u>Integrated Children's Services</u> (ICS) and are accessed via the 'Front Door Service'/<u>Kent Children's Services Portal.</u>
- 'Early help' is defined in 'Working together to safeguard children' as support for children of all ages that improves a family's resilience and outcomes or reduces the chance of a problem getting worse. It is not an individual service, but a system of support delivered by local authorities and their partners, including education providers, working together and taking collective responsibility to provide the right provision in their area.
 - If early help support is appropriate, the DSL (or a deputy) will lead on exploring internal resources available and liaising with other universal or additional services available via local agencies.
 - Where Intensive Support Early Help (provided by ICS, outlined in the <u>KSCMP support</u> <u>levels guidance</u>) is considered to be appropriate, the DSL (or deputy) will make a 'request for support' via the <u>Kent Children's Services Portal</u>.
 - Staff, including the DSL, may be required to work with other agencies and professionals in an early help assessment.
 - The DSL will keep all Early Help cases under constant review and consideration will be given to escalating concerns and/or seeking advice from the Front Door Service if the situation does not appear to be improving or is getting worse.
- Where a child is suffering, or is likely to suffer from harm, or is in immediate danger (for example, under section 17 or 47 of the Children Act), intensive or specialist support is required and a 'request for support' will be made immediately to Kent <u>Integrated Children's Services</u> (via the portal) and/or the police, in line with the Kent Support Level Guidance and KSCMP procedures.
 - The Lightyear Federation recognises that in situations where there are immediate child protection concerns for a child as identified in line with Support Level Guidance, it is NOT to investigate as a single agency, but to act in line with KSCMP guidance which may involve multi-agency decision making.
 - If they believe a child may be in need of support but are unclear whether a Request for Support should be submitted, the DSL may seek <u>advice or guidance</u> from a social worker via the Front Door Service before deciding next steps.
- The DSL, or a deputy DSL in the absence of the DSL will have overall responsibility for making referrals. However, all staff are made aware of the local process for making referrals to Integrated Children's Services and for statutory assessments under the Children Act 1989, especially section

17 (children in need) and section 47 (a child suffering, or likely to suffer, significant harm) that may follow a referral, along with the role they might be expected to play in such assessments.

- If staff have any concerns about a child's welfare, they are expected to act on them immediately. If staff are unsure if something is a safeguarding issue, they will speak to the DSL (or deputy). If in exceptional circumstances, a DSL is not available, this should not delay appropriate action being taken by staff.
 - Staff will speak to a member of the senior leadership team or may need to request a consultation with a social worker from the Front Door Service/make a request for support to the Front Door Service themselves; for contact information, see flowchart on page 5.
 - In these circumstances, any action taken by staff will be shared with a DSL as soon as is possible.
- In the event of a request for support to the Front Door Service being necessary, parents/carers will be informed and consent to this will be sought by the DSL in line with guidance provided by KSCMP and ICS. Parents/carers will always be informed in the case of a request for support being submitted by the school/nursery, unless there is a valid reason not to do so, for example, if informing them may put a child at risk of harm or could undermine a criminal investigation.
- If, after a request for support or any other planned external intervention, a child's situation does not
 appear to be improving, or concerns regarding receiving a decision or the decisions made, staff or
 the DSL will re-refer (if appropriate) and/or DSLs will follow the Kent Escalation and Professional Challenge Policy to ensure their concerns have been addressed and, most importantly, that the
 child's situation improves.
- DSLs and staff will be mindful of the need for the school/nursery to ensure any activity or support
 implemented to support children and/or families is recorded. Support provided by the
 school/nursery where families are struggling will be overseen and reviewed by the DSL on a
 regular basis to ensure activity does not obscure potential safeguarding concerns from the wider
 professional network.

3.3 Child Protection Records

- All safeguarding concerns, discussions, decisions, and reasons for those decisions, will be
 recorded electronically on Classcharts and submitted without delay. Staff members must record
 any concerns electronically and then notify the DSL or a DDSL via telephone or face-to-face
 immediately afterwards.
- Incident/concern forms are kept in the main office area should we be unable to access the online recording system.
- Records will be completed as soon as possible after the incident/event, using the child's words and
 the electronic system will include details of the recording member of staff and the time/date. Child
 protection records will record facts and not personal opinions. A body map will be completed if
 visible injuries to a child have been observed.
- If there is an immediate safeguarding concern the member of staff will consult with a DSL before completing the form as reporting urgent concerns takes priority.
- If members of staff are in any doubt about recording requirements, they will discuss their concerns with the DSL.

- Our child protection records will include a clear and comprehensive summary of any concerns, details of concerns which were followed up and resolved, a note of any action taken or not taken, how any decisions were reached and any outcomes.
- Child protection records are kept confidential and stored securely, and will only be accessible and
 available to those who have a right or professional need to see them. Child protection records will
 be kept for individual children and will be maintained separately from all other records relating to
 the child in the school/nursery. Child protection records are kept in accordance with data protection
 legislation and are retained centrally and securely by the DSL.

3.4 Transferring Child Protection Files

- All child protection records will be transferred in accordance with data protection legislation to the child's subsequent school/nursery, under confidential and separate cover as soon as possible; within 5 days for an in-year transfer or within the first 5 days of the start of a new term. Child protection files will be transferred securely to the new DSL, separately to the child's main file, and a confirmation of receipt will be obtained.
- In addition to the child protection file, the DSL will also consider if it would be appropriate to share any information with the DSL at the new school/nursery in advance of a child leaving, for example, information that would allow the new school to continue to provide support.
- Where the school/nursery receives child protection files from another setting, the DSL will ensure key staff such as DDSLs, and the Inclusion Team, will be made aware of relevant information as required.
- Where a child joins the school and no child protection files are received, the DSL will proactively seek to confirm from the previous setting whether any child protections exist for the learner, and if so, if the files have been sent.

3.5 Multi-agency working

- The Lightyear Federation recognises the pivotal role we have to play in multi-agency safeguarding arrangements and is committed to its responsibility to work within the KSCMP multi-agency safeguarding arrangements as identified within 'Working Together to Safeguard Children'.
- The Lightyear Federation leadership team, governing body and DSL will work to establish strong and co-operative local relationships with professionals in other agencies, including the safeguarding partners in line with local and national guidance. Some examples of multi-agency relationships may include, social workers, early help workers, health professionals (such as paediatricians, health visitors, mental health services and speech and language therapists), specialist teachers, education psychologists, other schools/settings where children attend more than one setting/provision and police.
- The Lightyear Federation recognises the importance of multi-agency working and is committed to working alongside partner agencies to provide a coordinated response to promote children's welfare and protect them from harm. This includes contributing to KSCMP processes as required, such as, participation in relevant safeguarding multi-agency plans and meetings, including Child Protection Conferences, Core Groups, Strategy Meetings, Child in Need meetings or other early help multi-agency meetings.

- Our schools and nursery will allow access for Kent Children's Social Work Service and, where appropriate, from a placing local authority, to conduct, or to consider whether to conduct, a section 17 or a section 47 assessment.
- The Executive Head Teacher, Head of School and DSL are aware of the requirement for children to have an Appropriate Adult (<u>PACE Code C 2019</u>) where there is a need for detention, treatment and questioning by police officers and will respond to concerns in line with our federation behaviour policy, which is informed by the DfE '<u>Searching</u>, <u>screening and confiscation at school</u>' guidance.

3.6 Confidentiality and information sharing

- The Lightyear Federation recognises our duty and powers to hold, use and share relevant information with appropriate agencies in matters relating to child protection at the earliest opportunity as per statutory guidance outlined within KCSIE, EYFS and WTSC.
- The Lightyear Federation has an appropriately trained Data Protection Officer (DPO) as required by the UK General Data Protection Regulations (UK GDPR) to ensure that our setting is compliant with all matters relating to confidentiality and information sharing requirements Our DPO is Vikki Reeves - The Lightyear Federation Business Director (bd@lightyear.kent.sch.uk).
- All staff are made aware of the need to protect the privacy of the children in their care, as well the legal requirements that exist to ensure that information relating to the child is handled in a way that ensures both confidentiality and safeguarding.
 - The Lightyear Federation will ensure staff are aware of our confidentiality expectations (available within our Staff Code of Conduct) and will ensure there is an area where staff may talk to parents and/or carers confidentially.
 - All staff are aware they cannot promise a child that they will not tell anyone about a report
 of any form of abuse, as this may not be in the best interests of the child.
 - Staff are made aware of their professional responsibility to be proactive in sharing information as early as possible to help identify, assess, and respond to risks or concerns about the safety and welfare of children; this may include sharing information with the DSL and with other agencies as appropriate.
- Staff will have due regard to the relevant data protection principles, which allow them to share and withhold personal information.
 - The Data Protection Act 2018, and the UK General Data Protection Regulation (UK GDPR) places duties on schools/nurseries and individuals to process personal information fairly and lawfully and to keep the information they hold safe and secure. The Data Protection Act 2018 and UK GDPR do not prevent the sharing of information for the purposes of keeping children safe. Fears about sharing information must not be allowed to stand in the way of the need to safeguard and promote the welfare and protect the safety of children.
 - All staff will be provided with training and information to ensure they understand the relevant data protection principles which allow them to share and/or withhold personal information. This will be delivered via safeguarding training (annually) and be documented within our data protection policy and staff code of conduct.
 - KCSIE, the <u>Information Commissioner's Office</u> (ICO), DfE <u>Data Protection in schools</u> <u>guidance</u> and DfE '<u>Information sharing advice for safeguarding practitioners</u> guidance provides further details regarding information sharing principles and expectations.
- The Executive Headteacher, Head of School and DSL will disclose relevant safeguarding information about a child with staff on a 'need to know' basis.

3.7 Complaints

- All members of the school/nursery community should feel able to raise or report any concerns
 about children's safety or potential failures in the federation's safeguarding regime. The federation
 has a complaints procedure available to parents, learners and members of staff and visitors who
 wish to report concerns or complaints. This can be found on the school website or requested from
 the school office.
- Whilst we encourage members of our community to report concerns and complaints directly to us, we recognise this may not always be possible. Children, young people, and adults who have experienced abuse at school/nursery can contact the NSPCC 'Report Abuse in Education' helpline on 0800 136 663 or via email: help@nspcc.org.uk
- Staff can also access the NSPCC whistleblowing helpline if they do not feel able to raise concerns regarding child protection failures internally.
 - Staff can call 0800 028 0285 (8:00 AM to 8:00 PM Monday to Friday) or email help@nspcc.org.uk.
- The leadership team at The Lightyear Federation will take all concerns and whistleblowing reports seriously, and all complaints will be considered and responded to in line with the relevant and appropriate process.
 - Anything that constitutes an allegation against a member of staff or volunteer will be dealt with in line with section 8 of this policy.

4 Specific Safeguarding Issues

- The Lightyear Federation is aware of the range of specific safeguarding issues and situations that can
 put children at greater risk of harm. Staff are made aware that concerns and risks may also be
 identified for children's family members or siblings, and/or young people, including for example,
 children on work experience placements/experience.
- In addition to Part One, DSLs, federation leaders and staff who work directly with children will read Annex B of KCSIE 2022 which contains important additional information about specific forms of abuse and safeguarding issues.
- Where staff are unsure how to respond to specific safeguarding issues, they should follow the processes as identified in part 3 of this policy and speak with the DSL or a deputy.

4.1 Child-on-child abuse

- All members of staff within the Lightyear Federation recognise that children can abuse other children; this is known as child-on-child abuse and can happen both inside and outside of school/nursery and online.
- The Lightyear Federation recognises that child-on-child abuse can take many forms, including but not limited to:
 - o Bullying, including cyberbullying, prejudice-based and discriminatory bullying
 - o Abuse in intimate personal relationships between children
 - Physical abuse which can include hitting, kicking, shaking, biting, hair pulling, or otherwise causing physical harm
 - Sexual violence and sexual harassment

- Consensual and non-consensual sharing of nudes and semi-nude images and/or videos (also known as sexting or youth produced sexual imagery)
- Causing someone to engage in sexual activity without consent, such as forcing someone to strip, touch themselves sexually, or to engage in sexual activity with a third party
- Upskirting (which is a criminal offence), which typically involves taking a picture under a
 person's clothing without their permission, with the intention of viewing their genitals or
 buttocks to obtain sexual gratification, or cause the victim humiliation, distress or alarm
- Initiation/hazing type violence and rituals
- Any allegations of child-on-child abuse will be recorded, investigated, and dealt with in line with this
 child protection policy and KCSIE (in particular, part two and five).
- The Lightyear Federation adopts a zero-tolerance approach to child-on-child abuse. We believe that
 abuse is abuse and it will never be tolerated or dismissed as "just banter", "just having a laugh", "part
 of growing up" or "boys being boys"; this can lead to a culture of unacceptable behaviours and can
 create an unsafe environment for children and a culture that normalises abuse, which can prevent
 children from coming forward to report it.
- All staff have a role to play in challenging inappropriate behaviours between children. Staff recognise
 that some child-on-child abuse issues may be affected by gender, age, ability and culture of those
 involved. For example, for gender based abuse, girls are more likely to be victims and boys more likely
 to be perpetrators.
- The Lightyear Federation recognises that even if there are no reported cases of child-on-child abuse, such abuse is still likely to be taking place and it may be the case that it is just not being reported. As such, it is important that staff speak to the DSL (or deputy) about any concerns regarding child-onchild abuse.
- To minimise the risk of child-on-child abuse, The Lightyear Federation will:
 - Implement a robust behaviour and anti-bullying policy
 - Involve children in safeguarding policies
 - o Provide a curriculum to meet the needs of keeping children safe
 - Ensure that children feel nurtured and safe to talk to the adults in school/nursery
 - o Ensure children know who they can talk to
 - o Provide a post-box for children to relay any worries and concerns
 - o Deliver an online safety curriculum through Project Evolve
 - o Forge positive relationships with parents
 - Celebrate diversity and promote equality in children and families
 - Recognise our young carers through targeted groups
- The Lightyear Federation want children to feel able to confidently report abuse and know their
 concerns will be treated seriously. All allegations of child-on-child abuse will be reported to the DSL
 and will be recorded, investigated, and dealt with in line with associated school/nursery policies,
 including child protection, anti-bullying, and behaviour. Children who experience abuse will be offered
 appropriate support, regardless of where the abuse takes place.
- Concerns about children's behaviour, including child-on-child abuse taking place offsite will be
 responded to as part of a partnership approach with learners and parents/carers. Offsite behaviour
 concerns will be recorded and responded to in line with existing appropriate policies, for example antibullying, acceptable use, behaviour and child protection policies.
- Alleged victims, alleged perpetrators and any other child affected by child-on-child abuse will be supported by:
 - Taking reports seriously

- Listening carefully
- Avoiding victim blaming
- o Providing appropriate pastoral support
- Working with families
- o Reviewing educational approaches
- o Following procedures as identified in other policies
- Where necessary and appropriate, informing other agencies

4.2 Sexual violence and sexual harassment

- When responding to concerns relating to child-on-child sexual violence or harassment, our federation will follow the guidance outlined in Part five of <u>KCSIE</u>.
- The Lightyear Federation recognises that sexual violence and sexual abuse can happen anywhere, and all staff will maintain an attitude of 'it could happen here.' The Lightyear Federation recognises sexual violence and sexual harassment can occur between two children of any age and sex. It can occur through a group of children sexually assaulting or sexually harassing a single child or group of children and can occur online and face to face (both physically and verbally). Sexual violence and sexual harassment is never acceptable.
- <u>All</u> victims of sexual violence or sexual harassment will be reassured that they are being taken seriously, regardless of how long it has taken them to come forward, and that they will be supported and kept safe. A victim will never be given the impression that they are creating a problem by reporting sexual violence or sexual harassment, or ever be made to feel ashamed for making a report.
- Abuse that occurs online or outside of the school/nursery will not be dismissed or downplayed and will be treated equally seriously and in line with relevant policies/procedures, for example anti-bullying, behaviour, child protection, online safety.
- The Lightyear Federation recognises that the law is in place to protect children rather than criminalise them, and this will be explained in such a way to children that avoids alarming or distressing them.
- The Lightyear Federation recognises that an initial disclosure to a trusted adult may only be the first
 incident reported, rather than representative of a singular incident and that trauma can impact
 memory, so children may not be able to recall all details or timeline of abuse. All staff will be aware
 certain children may face additional barriers to telling someone, for example because of their
 vulnerability, disability, sex, ethnicity, and/or sexual orientation.
- The DSL (or deputy) is likely to have a complete safeguarding picture and will be the most appropriate person to advise on the initial response.
 - The DSL will make an immediate risk and needs assessment which will be considered on a case-by-case basis which explores how best to support and protect the victim and the alleged perpetrator, and any other children involved/impacted, in line with part five of KCSIE and relevant local/national guidance and support, for example KSCMP procedures.
 - The risk and needs assessment will be recorded and kept under review and will consider the victim (especially their protection and support), the alleged perpetrator, and all other children, and staff and any actions that are required to protect them.
 - Any concerns involving an online element will take place in accordance with relevant local/national guidance and advice.
- Reports will initially be managed internally by the school/nursery and where necessary will be referred
 to <u>Integrated Children's Services</u> (Early Help and/or Children's Social Work Service) and/or the police.
 Important considerations which may influence this decision include:
 - o the wishes of the victim in terms of how they want to proceed.

- the nature of the alleged incident(s), including whether a crime may have been committed and/or whether Harmful Sexual Behavior has been displayed.
- the ages of the children involved.
- the developmental stages of the children involved.
- any power imbalance between the children.
- if the alleged incident is a one-off or a sustained pattern of abuse sexual abuse can be accompanied by other forms of abuse and a sustained pattern may not just be of a sexual nature.
- that sexual violence and sexual harassment can take place within intimate personal relationships between children.
- understanding intra familial harms and any necessary support for siblings following incidents.
- o whether there are any ongoing risks to the victim, other children or staff.
- any other related issues and wider context, including any links to child sexual exploitation and child criminal exploitation.
- The school/nursery will in most instances, engage with both the victim's and alleged perpetrator's parents/carers when there has been a report of sexual violence; this might not be necessary or proportionate in the case of sexual harassment and will depend on a case-by-case basis. The exception to this is if there is a reason to believe informing a parent/carer will put a child at additional risk. Any information shared with parents/carers will be in line with information sharing expectations, our confidentiality policy, and any data protection requirements, and where they are involved, will be subject to discussion with other agencies (for example Children's Social Work Service and/or the police) to ensure a consistent approach is taken.
- If at any stage the DSL is unsure if a request for support is appropriate, advice may be sought from the Front Door Service.

4.3 Nude and/or semi-nude image sharing by children

- The Lightyear Federation recognises that consensual and non-consensual sharing of nudes and seminude images and/or videos (also known as youth produced/involved sexual imagery or "sexting") can be a safeguarding issue; all concerns will be reported to and dealt with by the DSL (or deputy).
- When made aware of concerns involving consensual and non-consensual sharing of nudes and seminude images and/or videos by children, staff are advised:
 - o to report any concerns to the DSL immediately.
 - never to view, copy, print, share, forward, store or save the imagery, or ask a child to share or download it – this may be illegal. If staff have already inadvertently viewed imagery, this will be immediately reported to the DSL.
 - o not to delete the imagery or ask the child to delete it.
 - o to avoid saying or doing anything to blame or shame any children involved.
 - to reassure the child(ren) involved and explain that the DSL will be informed so they can receive appropriate support and help. Do not promise confidentiality, as other agencies may need to be informed and be involved.
 - o not to investigate or ask the child(ren) involved to disclose information regarding the imagery
 - to not share information about the incident with other members of staff, children, or parents/carers, including the families and child(ren) involved in the incident; this is the responsibility of the DSL.
- DSLs will respond to concerns in line with the non-statutory UKCIS guidance: 'Sharing nudes and semi-nudes: advice for education settings working with children and young people' and the local KSCMP guidance. When made aware of a concern involving consensual and non-consensual sharing of nudes and semi-nude images and/or videos:

- The DSL will hold an initial review meeting to explore the context and ensure appropriate and proportionate safeguarding action is taken in the best interests of any child involved. This may mean speaking with relevant staff and the children involved as appropriate.
- Parents/carers will be informed at an early stage and be involved in the process to best support children, unless there is good reason to believe that involving them would put a child at risk of harm.
- o All decisions and action taken will be recorded in line with our child protection procedures.
- o A referral will be made to ICS via the Children's Portal and/or the police immediately if:
 - the incident involves an adult (over 18).
 - there is reason to believe that a child has been coerced, blackmailed, or groomed, or there are concerns about their capacity to consent, for example, age of the child or they have special educational needs.
 - the image/videos involve sexual acts and a child under the age of thirteen, depict sexual acts which are unusual for the child's developmental stage, or are violent.
 - a child is at immediate risk of harm owing to the sharing of nudes and semi-nudes.
- The DSL may choose to involve other agencies at any time if further information/concerns are disclosed at a later date.
- If DSLs are unsure if a request for support is appropriate, advice may be sought from the Front Door Service.

4.4 Child Sexual Exploitation (CSE) and Child Criminal Exploitation (CCE)

- The Lightyear Federation recognises that both CSE and CCE are forms of abuse that occur where an individual or group takes advantage of an imbalance in power to coerce, manipulate or deceive a child into taking part in sexual or criminal activity, in exchange for something the victim needs or wants, and/or for the financial advantage or increased status of the perpetrator or facilitator and/or through violence or the threat of violence. CSE and CCE can affect children, both male and female and can include children who have been moved (commonly referred to as trafficking) for the purpose of exploitation.
- The Lightyear Federation recognises that children can become trapped in CCE as perpetrators can threaten victims and their families with violence or entrap and coerce them into debt. Children involved in criminal exploitation often commit crimes themselves which can mean their vulnerability as victims is not always recognised (particularly older children) and they are not treated as victims, despite the harm they have experienced. The experience of girls who are criminally exploited can also be very different to that of boys. We also recognise that boys and girls being criminally exploited may be at higher risk of child sexual exploitation (CSE).
- The Lightyear Federation recognises that CSE can occur over time or be a one-off occurrence and
 may happen without the child's immediate knowledge, for example through others sharing videos or
 images of them on social media. CSE can affect any child who has been coerced into engaging in
 sexual activities and includes 16 and 17 year olds who can legally consent to have sex. Some children
 may not realise they are being exploited, for example they may believe they are in a genuine romantic
 relationship.
- If staff are concerned that a child may be at risk of CSE or CCE, immediate action should be taken by speaking to the DSL or a deputy.

4.5 Serious violence

 All staff are aware of the indicators which may signal children are at risk from or are involved with serious violent crime. These may include unexplained gifts or new possessions, increased absence from school, a change in friendships or relationships with older individuals or groups, a significant decline in performance, signs of self-harm or a significant change in wellbeing, or signs of assault or unexplained injuries. Unexplained gifts or new possessions could also indicate that children have been approached by, or are involved with, individuals associated with criminal networks or gangs and may be at risk of CCE.

- The Lightyear Federation recognises that the likelihood of involvement in serious violence may be
 increased by factors such as being male, having been frequently absent or permanently excluded,
 having experienced child maltreatment and having been involved in offending, such as theft or
 robbery. Additionally, violence can peak in the hours just before or just after school, when children are
 travelling to and from school and these may be particularly risky times for children involved in serious
 violence.
- Any concerns regarding serious violence will be reported and responded to in line with other child
 protection concerns by speaking with a DSL or deputy. The initial response to child victims is important
 and staff will take any allegations seriously and work in ways that support children and keep them
 safe.

4.6 Modern Slavery and the National Referral Mechanism (NRM)

- Modern slavery encompasses human trafficking and slavery, servitude and forced or compulsory labour. Exploitation can take many forms, including sexual exploitation, forced labour, slavery, servitude, forced criminality and the removal of organs. Further information on the signs that someone may be a victim of modern slavery, the support available to victims and how to refer them to the NRM is available in the Statutory Guidance: Modern slavery: how to identify and support victims.
- If there are concerns that any member of the community is a victim or involved with modern slavery, concerns should be shared with a DSL or deputy and will and responded to in line with this policy.

4.7 So-called Honour Based Abuse (HBA)

- So-called 'honour'-based abuse (HBA) encompasses incidents or crimes which have been committed
 to protect or defend the honour of the family and/or the community, including female genital mutilation
 (FGM), forced marriage, and practices such as breast ironing. Abuse committed in the context of
 preserving 'honour' often involves a wider network of family or community pressure and can include
 multiple perpetrators.
- All forms of HBA are abuse, regardless of the motivation, and concerns will be responded to in line with section 3 of this policy. Staff will report any concerns about HBA to the DSL (or a deputy). If there is an immediate threat, the police will be contacted.
- All staff will speak to the DSL (or deputy) if they have any concerns about forced marriage. Staff can also contact the Forced Marriage Unit if they need advice or information: 020 7008 0151 or fmu@fcdo.gov.uk
- Whilst all staff will speak to the DSL (or deputy) if they have any concerns about risk or suspected cases of FGM, there is a specific legal duty on teachers.
 - Section 5B of the Female Genital Mutilation Act 2003 (as inserted by section 74 of the Serious Crime Act 2015) places a statutory duty upon teachers in England and Wales, to <u>personally</u> report to the police where they discover that FGM appears to have been carried out.

- It will be rare for teachers to see visual evidence, and they should not be examining children, however teachers who do not personally report such concerns may face disciplinary sanctions.
 Further information on when and how to make a report can be found at: Mandatory reporting of female genital mutilation procedural information and FGM Mandatory reporting Duty Fact Sheet.
- Unless the teacher has good reason not to, they are expected to also discuss any FGM concerns with the DSL (or a deputy), and Kent Integrated Childrens Services should be informed as appropriate.

4.7 Preventing radicalisation

- The Lightyear Federation recognises that children may be susceptible to radicalisation into terrorism.
- The Lightyear Federation is aware of our duty under section 26 of the Counter-Terrorism and Security Act 2015 (the CTSA 2015), to have "due regard to the need to prevent people from being drawn into terrorism", also known as the Prevent duty and the <u>specific obligations</u> placed upon us as an education provider regarding risk assessments, working in partnership, staff training, and IT policies.
- It is possible to protect people from extremist ideology and intervene to prevent those at risk of radicalisation being drawn to terrorism. As with other safeguarding risks, staff should be alert to changes in children's behaviour, which could indicate that they may be in need of help or protection
- All staff have received appropriate training to enable them to be alert to changes in children's behaviour which could <u>indicate that they may need help or protection from radicalisation</u>. Online Prevent Training provided by the Home Office is completed by all staff at induction and is then updated annually
- Staff will be supported to use their judgement in identifying children who might be at risk of radicalisation and will act proportionately; staff will report concerns to the DSL (or a deputy), who, where appropriate, will follow the <u>local procedures</u> in regard to making a Prevent referral.
- If there is an immediate threat to safety, the police will be contacted via 999.
- Where a child is receiving support regarding concerns relating to preventing radicalisation, for example, through the 'Channel' programme, the DSL will consider if it would be appropriate to share any information if/when a child leaves to attend any new schools/colleges, so support can be put in place in place for when the child arrives.

4.8 Cybercrime

- The Lightyear Federation recognises that children with particular skill and interest in computing and technology may inadvertently or deliberately stray into 'cyber-enabled' (crimes that can happen offline but are enabled at scale and at speed online) or 'cyber dependent' (crimes that can be committed only by using a computer/internet enabled device) cybercrime.
- If staff are concerned that a child may be at risk of becoming involved in cyber-dependent cybercrime, the DSL or a deputy will be informed, and consideration will be given to accessing local support and/or referring into the <u>Cyber Choices</u> programme, which aims to intervene when young people are at risk of committing, or being drawn into, low level cyber-dependent offences and divert them to a more positive use of their skills and interests.
- Where there are concerns about 'cyber-enabled' crime such as fraud, purchasing of illegal drugs online, child sexual abuse and exploitation, or other areas of concern such as online bullying or

general online safety, they will be responded to in line with the child protection and other appropriate policies.

 The DSL (or deputy) may also seek advice from Kent Police and/or the Front Door Service regarding cybercrime.

4.9 Domestic abuse

- The Lightyear Federation recognises that:
 - domestic abuse can encompass a wide range of behaviours and may be a single incident or a pattern of incidents.
 - domestic abuse can include, but is not limited to, psychological (including coercive control), physical, sexual, economic, or emotional abuse.
 - children can be victims of domestic abuse if they see, hear, or experience the effects of abuse at home and/or suffer domestic abuse in their own intimate relationships (teenage relationship abuse).
 - anyone can be a victim of domestic abuse, regardless of sexual identity, age, ethnicity, socioeconomic status, sexuality or background, and domestic abuse can take place inside or outside of the home.
 - domestic abuse can take place within different types of relationships, including ex-partners and family members.
 - there is always a potential for domestic abuse to take place when parents/families separate, or for existing domestic abuse to persist or escalate post separation.
 - o domestic abuse can have a detrimental and long-term impact on children's health, well-being, development, and ability to learn.
 - o domestic abuse concerns will not be looked at in isolation and our response will be considered as part of a holistic approach which takes into account children's lived experiences.
 - o it is important not to use victim blaming language and to adopt a trauma informed approach when responding to concerns relating to domestic abuse.
- If staff are concerned that a child may be at risk of seeing, hearing, or experiencing domestic abuse in their home or in their own intimate relationships, immediate action should be taken by speaking to the DSL or a deputy.
- The schools within The Lightyear Federation are registered as <u>Operation Encompass Schools</u>. This
 means we work in partnership with Kent Police to provide support to children experiencing the effects
 of domestic abuse. An Operation Encompass notification is sent to the school when the police are
 called to an incident of domestic abuse and there are children in the household; the police are
 expected to inform schools before the child(ren) arrive the following day.
 - Operation Encompass notifications help ensure that we have up to date and relevant information about children's circumstances and enable us to put immediate support in place according to the child's needs.
 - Operation Encompass does not replace statutory safeguarding procedures and where appropriate, a referral to the Front Door Service will be made if there are any concerns about a child's welfare.
 - Where the school is unsure of how to respond to a notification, advice may be sought from the Front Door Service or the Operation Encompass helpline which is available 8AM to 1PM, Monday to Friday on 0204 513 9990.

4.10 Mental health

• All staff recognise that mental health problems can, in some cases, be an indicator that a child has suffered or is at risk of suffering abuse, neglect or exploitation.

- Staff are aware that children's experiences, for example where children have suffered abuse and neglect, or other potentially traumatic Adverse Childhood Experiences (ACEs), can impact on their mental health, behaviour, and education.
- Staff are well placed to observe children day-to-day and identify those whose behaviour suggests that they may be experiencing a mental health problem or be at risk of developing one.
- If staff have a mental health concern about a child that is also a safeguarding concern, immediate action should be taken by speaking to the DSL or a deputy.

4.11 Bruising in non-mobile children

- Bruising in babies, infants or children with complex needs that are not mobile (meaning a child who is
 unable to move independently through rolling, crawling, cruising, or bottom shuffling) is unusual and
 should always be explored.
- If our setting is concerned about actual or suspected bruising on a non-mobile child, we will respond in line with the '<u>Kent and Medway Protocol for the Management of Actual or Suspected Bruising in</u> <u>Infants and Children who are not Independently Mobile</u>' procedures (2.2.8 of the KSCMP procedures). In summary, these procedures state:
 - If a child appears seriously ill or injured, emergency treatment should be sought through an emergency department (ED) and the Kent ICS should be notified of the concern and the child's location.
 - In all other cases:
 - Staff must inform the DSL immediately and describe and document accurately on a body map, the size, shape, colour, and position of the mark/s on the head and/or body.
 - Any explanation of the history of the injury or comments by the parents/carers will be documented accurately (verbatim) in the child's record, along with the body map.
 - If there is a concern about parental response to the injury, no explanation, or an explanation that is inadequate, unlikely or does not rule out abuse or neglect, an immediate referral will be made to Kent ICS, who have responsibility for arranging further multi-agency assessments.
 - If there are concerns regarding the immediate safety of the child or staff, the police will be called

If the setting is in any doubt as to how to respond to bruising on a non-mobile child, advice may be sought from the Front Door Service.

5 Supporting Children Potentially at Greater Risk of Harm

• Whilst <u>all</u> children should be protected, The Lightyear Federation acknowledge that some groups of children are potentially at greater risk of harm. This can include the following groups:

5.1 Safeguarding children with Special Educational Needs or Disabilities (SEND)

- The Lightyear Federation acknowledges that children with special educational needs or disabilities (SEND) or certain health conditions can face additional safeguarding challenges and barriers for recognising abuse, neglect or exploitation.
- The Lightyear Federation recognises that children with SEND may face additional communication barriers and experience difficulties in managing or reporting abuse or challenges. Children with SEND will be supported to communicate and ensure that their voice is heard and acted upon.

- All members of staff are encouraged to appropriately explore potential indicators of abuse, neglect and exploitation, such as behaviour, mood changes or injuries and not to assume that they are related to the child's special educational needs or disability.
- Members of staff are encouraged to be aware that children with SEND, or certain medical conditions, can be disproportionally impacted by safeguarding concerns or behaviour, such as exploitation, peer group isolation or bullying including prejudice-based bullying, without outwardly showing any signs.
- To address these additional challenges, our schools and nursery will always consider implementing extra pastoral support and attention for children with SEND. The DSL will work closely with the SENCO (Louise Summers/Fiona Roberts) to plan support as required.
- Our federation has robust intimate/personal care policies which ensure that the health, safety, independence, and welfare of children is promoted, and their dignity and privacy are respected.
 Arrangements for intimate and personal care are open and transparent and accompanied by robust recording systems. Further information and our Intimate Care Policy can be found on our school websites.

5.2 Children requiring mental health support

- Our federation has an important role to play in supporting the mental health and wellbeing of our leaners. Mental health problems can, in some cases, be an indicator that a child has suffered or is at risk of suffering abuse, neglect or exploitation.
- Staff are aware that children's experiences, for example where children have suffered abuse and neglect, or other potentially traumatic Adverse Childhood Experiences (ACEs), can impact on their mental health, behaviour and education.
- Where there are concerns regarding possible mental health problems for learners, staff should speak
 with the Senior Mental Health Lead (Hannah Ferris) or complete a referral into the Inclusion Team. If
 staff have a mental health concern that is also a safeguarding concern, immediate action should be
 taken by speaking to a DSL or Deputy.
- Age/ability appropriate education will be provided to our learners to help promote positive health, wellbeing, and resilience via assemblies, our RSE curriculum and an ongoing whole federation nurturing ethos (see our Mental Wealth and Nurture Policy for more information).

5.3 Children who are absent from education

- We will follow up with absences in a timely manner and in-line with our attendance policy. If a child is
 absent from school or nursery with notification from a parent/carer then attempts will be made to
 contact the parent/carer and alternative emergency contacts.
- Children being absent from education for prolonged periods and/or on repeat occasions can act as a
 vital warning sign to a range of safeguarding issues including neglect, child sexual and child criminal
 exploitation particularly county lines.
- A robust response to children who are absent from education for prolonged periods and/or on repeat occasions will support the identification of such abuse and may help prevent the risk of children going missing in the future. This includes when problems are first emerging and also where children are already known to Kent Integrated Children's Services and/or have a social worker (such as a child who is a child in need or who has a child protection plan, or is a looked after child), where being absent from education may increase known safeguarding risks within the family or in the community.

- Where possible, we will hold more than one emergency contact number for each child, so we have additional options to make contact with a responsible adult if a child missing education is also identified as a welfare and/or safeguarding concern. There is an expectation that emergency contact information will be held for both parents, unless doing so would put a child at risk of harm, for example a court or other legal order preventing access is in place. If this is the case, this information will be recorded on the child's safeguarding file.
- Where the school/nursery have concerns that a child has unexplainable and/or persistent absences
 from education and/or is missing from education, we will respond in line with our statutory duties (DfE:
 Children missing education) and local policies. Local support is available via the Kent PRU, Inclusion
 and Attendance Service (PIAS).
- If there are safeguarding concerns relating to a child's absence, this will be followed up with in line with our attendance policy and a police welfare check may be requested.

5.4 Children attending alternative provision

- Where The Lightyear Federation places a child with an alternative provision provider, we continue to be responsible for the safeguarding of that child. This includes:
 - a. having records of the address of the alternative provider and any subcontracted provision or satellite sites the child may attend.
 - b. regularly reviewing (at least half termly) the alternative provision placements made to provide assurance that the child is regularly attending and the placement continues to be safe and meets the child's needs.
- Where safeguarding concerns arise, placements will be immediately reviewed, and terminated, if necessary, unless or until those concerns have been satisfactorily addressed.

5.5 Elective Home Education (EHE)

- Where a parent/carer expresses their intention to remove a child from school with a view to educating at home, we will respond in line with <u>national Elective Home Education guidance</u> and local <u>Kent</u> guidance.
- We will work together with parents/carers and other key professionals and organisations to ensure decisions are made in the best interest of the child.

5.6 Children who may benefit from Early Help

- Any child may benefit from early help, but all staff should be particularly alert to the potential need for early help for a child who:
 - is disabled or has certain health conditions and has specific additional needs
 - has special educational needs (whether or not they have a statutory Education, Health and Care plan)
 - has a mental health need
 - o is a young carer
 - is showing signs of being drawn in to anti-social or criminal behaviour, including gang involvement and association with organised crime groups or county lines
 - o is frequently missing/goes missing from education, home or care,
 - has experienced multiple suspensions, is at risk of being permanently excluded from schools, colleges and in Alternative Provision or a Pupil Referral Unit.
 - o is at risk of modern slavery, trafficking, sexual and/or criminal exploitation

- is at risk of being radicalised or exploited
- o has a parent or carer in custody, or is affected by parental offending
- is in a family circumstance presenting challenges for the child, such as drug and alcohol misuse, adult mental health issues and domestic abuse
- o is misusing alcohol and other drugs themselves
- is at risk of so-called 'honour'-based abuse such as Female Genital Mutilation or Forced Marriage
- is a privately fostered child.
- Where it is identified a child may need early help, staff and DSLs will respond in line with section 3 of this policy.

5.7 Children who need a social worker (child in need and child protection plans)

- The DSL will hold details of social workers working with children in the school /nursery so that decisions can be made in the best interests of the child's safety, welfare, and educational outcomes.
- Where children have a social worker, this will inform decisions about their safety and promoting their welfare, for example, responding to unauthorised absence and provision of pastoral and/or academic support.

5.8 Looked after children (including kinship care), previously looked after children and care leavers

- The Lightyear Federation recognises the common reason for children becoming looked after is as a result of abuse, neglect and/or exploitation and a previously looked after child also potentially remains vulnerable.
- The federation has appointed a 'designated teacher' (Hannah Ferris, Safeguarding and Pastoral Director) who works with local authorities, including the <u>Virtual School Kent (including the virtual school head)</u>, to promote the educational achievement of registered pupils who are looked after or who have been previously looked after, including those in <u>kinship care</u>.
- The designated teacher, who is also the DSL, will ensure appropriate staff have the information they need in relation to a child's looked after legal status, contact arrangements with birth parents or those with parental responsibility, care arrangements and the levels of authority delegated to the carer by the authority looking after them.
- Where a child is looked after, the DSL will hold details of the social worker and the name of the virtual school head in the authority that looks after the child.
- Where a child is leaving care, the DSL will hold details of the local authority Personal Advisor appointed to guide and support them and will liaise with them as necessary regarding any issues of concern.

5.9 Children who are privately fostered

<u>Private fostering</u> occurs when a child under the age of 16 (under 18 for children with a disability) is
provided with care and accommodation by a person who is not a parent, person with parental
responsibility for them or a relative in their own home. A child is not privately fostered if the person
caring for and accommodating them has done so for less than 28 days and does not intend to do so for
longer.

 Where private fostering arrangements come to our attention, for example, through the normal course of their interaction and promotion of learning activities with children, we must notify Kent Integrated Children's Services in line with the local <u>KSCMP arrangements</u> in order to allow the local authority to check the arrangement is suitable and safe for the child.

5.10 Children who are Lesbian, Gay, Bisexual, or Gender Questioning

- The fact that a child may be lesbian, gay, bisexual or gender questioning is not in itself an inherent risk
 factor for harm, however, The Lightyear Federation recognises that children who are lesbian, gay,
 bisexual or gender questioning or are perceived by other children to be lesbian, gay, bisexual or gender
 questioning (whether they are or not) can be targeted by other children or others within the wider
 community.
- When supporting a gender questioning child, the federation will consider the broad range of their
 individual needs, in partnership with the child's parents (other than in the rare circumstances where
 involving parents would constitute a significant risk of harm to the child), including any clinical advice
 that is available and how to address wider vulnerabilities such as to support any complex mental health
 and psychosocial needs and to manage the risk of bullying.
- The Lightyear Federation recognises risks can be compounded where children who are lesbian, gay, bisexual or gender questioning lack a trusted adult with whom they can be open. Appropriate education is included within our Relationships, Sex Education and Health Education curriculum, and our staff will endeavour to reduce the additional barriers faced and provide a safe space that facilitates a culture where children can speak out or share any concerns.

6 Online Safety

- It is essential that children are safeguarded from potentially harmful and inappropriate material or behaviours online. The Lightyear Federation will adopt a whole federation approach to online safety which will empower, protect, and educate our learners and staff in their use of technology, and establish mechanisms to identify, intervene in, and escalate any concerns where appropriate.
- The Lightyear Federation will ensure online safety is considered as a running and interrelated theme when devising and implementing our policies and procedures, and when planning our curriculum, staff training, the role and responsibilities of the DSL and parental engagement.
- The Lightyear Federation identifies that the breadth of issues classified within online safety is considerable, but can be categorised into four areas of risk:
 - Content: being exposed to illegal, inappropriate or harmful content, for example: pornography, racism, misogyny, self-harm, suicide, anti-Semitism, radicalisation, extremism, misinformation, disinformation (including fake news) and conspiracy theories.
 - Contact: being subjected to harmful online interaction with other users. For example peer to peer pressure, commercial advertising and adults posing as children or young adults with the intention to groom or exploit them for sexual, criminal, financial or other purposes.
 - Conduct: personal online behaviour that increases the likelihood of, or causes, harm. For example, making, sending and receiving explicit images (including consensual and nonconsensual sharing of nudes and semi-nudes and/or pornography), sharing other explicit images and online bullying.
 - Commerce: risks such as online gambling, inappropriate advertising, phishing and or financial scams.
- The Lightyear Federation recognises that technology, and the risks and harms related to it, evolve and change rapidly. The schools and nursery within our federation will carry out an annual review of our

approaches to online safety, supported by an annual risk assessment, which considers and reflects the current risks our children face online.

- The Executive Headteacher and Head of School will be informed of any online safety concerns by the DSL, as appropriate. The named governor for safeguarding will report on online safety practice and incidents, including outcomes, on a regular basis to the wider governing body.
- The DSL has overall responsibility for online safety across The Lightyear Federation but will liaise with other members of staff, for example ICT technicians, leadership teams and curriculum leads as necessary.

The DSL will respond to online safety concerns in line with our child protection and other associated policies, including our anti-bullying policy, behaviour police, online safety policy and behaviour policies.

- o Internal sanctions and/or support will be implemented as appropriate.
- Where necessary, concerns will be escalated and reported to relevant partner agencies in line with local policies and procedures.
- The Lightyear Federation use a wide range of technology. This includes: computers, laptops, tablets and other digital devices, the internet, our learning platform, intranet and email systems.
- All federation owned devices and systems will be used in accordance with our online safety and acceptable use policies and with appropriate safety and security measures in place. These policies can be found on the school websites.
- The Lightyear Federation recognises that when used safely, effectively and with the right infrastructure in place, generative artificial intelligence (AI) tools have many uses which can benefit our entire federation community. However, it is important to recognise that AI tools can also pose safeguarding risks to our community as well as moral, ethical and legal concerns. This includes, but is not limited to:
 - exposure to inappropriate or harmful content, including bullying, harassment, abuse and exploitation
 - o privacy and data protection breaches/risks
 - intellectual property infringements
 - academic integrity challenges such as plagiarism and cheating
 - o exposure to inaccurate, misleading, or biased content.

Further information about these systems can be found in our Online Safety policy.

- The Lightyear Federation recognises the specific risks that can be posed by mobile and smart technology, including mobile/smart phones, cameras, wearable technology and any other electronic devices with imaging and/or sharing capabilities. In accordance with KCSIE and EYFS, our federation has appropriate mobile and smart technology and image use policies in place, which are shared and understood by all members of the community. These policies can be found within our Online Safety and Acceptable Use Policies (available via the school websites)
- The Lightyear Federation will do all we reasonably can to limit children's exposure to online harms through federation provided devices and networks and in line with the requirements of the Prevent Duty and KCSIE, we will ensure that appropriate filtering and monitoring systems are in place. This includes ensuring application of appropriate filtering and monitoring to both static content, as well as dynamic and AI-generated materials, products and/or systems used.
- Whilst filtering and monitoring is an important part of our online safety responsibilities, it is only one
 part of our approach, and we recognise that we cannot rely on filtering and monitoring alone to
 safeguard our pupils/students. Effective safeguarding practice, robust policies, appropriate classroom/
 behaviour management and regular education/ training about safe and responsible use is essential

and expected. Further information about these systems, including remote and online learning, can be found in our Online Safety Policy (available via the school websites)

- Our Governing Body has overall strategic responsibility for our filtering and monitoring approaches, including ensuring that our filtering and monitoring systems are regularly reviewed, and that the leadership team and relevant staff have an awareness and understanding of the appropriate filtering and monitoring provisions in place, manage them effectively and know how to escalate safeguarding concerns when identified.
- Hannah Ferris, a member of the senior leadership team and Caroline Allen, David Lea and Rob Doubtfire, governors, are responsible for ensuring that our federation has met the DfE <u>Filtering and monitoring standards</u> for schools and colleges.
- All members of staff are provided with an understanding of the expectations, applicable roles and
 responsibilities in relation to filtering and monitoring as part of our induction process, and in our child
 protection staff training. All staff will read and agree to follow our Online Safety Policy and Acceptable
 Use Policy. This will be updated annually.
- All staff, children and parents/carers have a responsibility to follow this policy to report and record any filtering or monitoring concerns.
- Information about online safety training for staff, roles and responsibilities and online safety education for learners is documented within our Online Safety policy

7 Staff Engagement and Expectations

7.1 Staff awareness, induction and training

- All members of staff have been provided with a copy of part one of 'Keeping Children Safe in Education' which covers safeguarding information for staff.
 - o Federation leaders, including the DSL and governors will read KCSIE in its entirety.
 - Federation leaders and all members of staff who work directly with children will read annex B of KCSIE.
 - All members of staff have signed to confirm that they have read and understood the national guidance shared with them. This list will be kept with the Single Central Record and a signed copy of compliance is kept within individual personnel files.
- It is a requirement that all members of staff have access to this policy and sign to say they have read
 and understood its contents. All staff are expected to re-read this policy at least annually (and
 following any updates) to ensure they understand our expectations and requirements.
- All new staff and volunteers (including agency and third-party staff) receive safeguarding and child protection training (including online safety, which, amongst other things, will include ensuring an understanding of the expectations, applicable roles and responsibilities in relation to filtering and monitoring) to ensure they are aware of the school and federation's internal safeguarding processes, as part of their induction. This training is regularly updated and is in line with advice from the local safeguarding partners and explores the Kent processes to follow. This will be achieved through:
 - Full safeguarding induction for all new federation staff which will be delivered by DSL
 - Safeguarding and Child Protection Leaflets for third-party staff and visitors to site
 - o DSL information on visitor and staff lanyards

- Safeguarding videos with key information for governors, volunteers and regular agency staff
- Safeguarding posters displayed in communal areas
- All staff members (including agency and third-party staff) will receive appropriate child protection training (including online safety) to ensure they are aware of a range of safeguarding issues and how to report concerns. For staff, this training will be updated at least annually as part of our first federation INSET day of the academic year. For third-party and agency staff this will be updated via a safeguarding video which will be provided annually.
- Online safety training for staff will be integrated, aligned and considered as part of the whole
 federation safeguarding approach and wider staff training and curriculum planning. To achieve this,
 online safety will be included in whole federation safeguarding training, discussed as part of
 safeguarding within meetings as a rolling agenda item and included as an integral part of new staff
 induction. Online safety scenarios will be included for discussion in staff meetings throughout the year.
- In addition to specific child protection training, all staff will receive regular safeguarding and child
 protection updates, at least annually, to provide them with relevant skills and knowledge to safeguard
 children effectively. This will be through staff meetings, newsletters, posters, emails and specific
 training as appropriate.
- The Lightyear Federation recognises the expertise staff build by undertaking safeguarding training and from managing safeguarding concerns on a daily basis and staff are encouraged to contribute to and shape federation safeguarding arrangements and child protection policies. This will be achieved by asking for feedback and inviting input through staff meetings.
- All governors receive appropriate safeguarding and child protection (including online safety) training at
 induction. This training equips them with the knowledge to provide strategic challenge to test and
 assure that our safeguarding policies and procedures are effective and support the delivery of a robust
 whole federation approach to safeguarding. This will be updated annually during the first Governing
 Body meeting each year.
- The DSL and Executive Headteacher/Heads of School will provide an annual report to the Governing Body detailing safeguarding training undertaken by all staff and will maintain an up to date record of who has been trained.

7.2 Safer working practice

- The Lightyear Federation takes steps as outlined in this and other relevant policies to ensure
 processes are in place for staff that promote continuous vigilance, maintain an environment that deters
 and prevents abuse and challenges inappropriate behaviour.
- All members of staff are required to work within our clear guidelines on safer working practice as outlined in the staff code of conduct.
- The DSL will ensure that all staff and volunteers (including contractors) are aware of the federation
 expectations regarding safe and professional practice via the staff code of conduct and Acceptable
 Use Policy (AUP).
- Staff will be made aware of the federation behaviour management and physical intervention policies.
 Staff will manage behaviour effectively to ensure a good and safe educational environment and will have a clear understanding of the needs of all children. Any physical interventions and/or use of reasonable force will be in line with our agreed policy and procedures, and national guidance.

All staff will be made aware of the professional risks associated with the use of social media and
electronic communication (such as email, mobile phones, texting, social networking). Staff will adhere
to relevant federation policies including staff code of conduct, information about mobile and smart
technology, Acceptable Use Policies (AUPs), and online safety.

7.3 Supervision and support

- The induction process will include familiarisation with child protection responsibilities and procedures to be followed if members of staff have any concerns about a child's safety or welfare.
- The Lightyear Federation will ensure that members of staff who are working within the foundation stage are provided with appropriate supervision in accordance with the statutory requirements of Early Years Foundation Stage (EYFS).
- The Lightyear Federation will provide appropriate supervision and support for members of staff to ensure that:
 - All staff are competent to carry out their responsibilities for safeguarding and promoting the welfare of children
 - All staff are supported by the DSL in their safeguarding role.
 - All members of staff have regular reviews of their own practice to ensure they improve over time.
- Any member of staff affected by issues arising from concerns for children's welfare or safety can seek support from the DSL.
- The DSL will also put staff in touch with outside agencies for professional support if they so wish. Staff
 can also approach organisations such as their Union, the Education Support Partnership or other
 similar organisations directly. Staff employed by The Lightyear Federation are also able to access
 confidential counselling via the <u>Support Line Partnership</u>.

8 Safer Recruitment and Allegations Against Staff

8.1 Safer recruitment and safeguarding checks

- The Lightyear Federation is committed to ensure that we develop a safe culture and that all steps are taken to recruit staff and volunteers who are safe to work with our children and staff. We recognise that we must ensure that people working with children in our setting are suitable, have the relevant qualifications/training and have passed any required checks to fulfil their roles.
 - The Lightyear Federation will follow Part three, 'Safer recruitment' of Keeping Children Safe in Education and relevant guidance from The Disclosure and Barring Service (DBS)
 - The Governing Body and leadership team are responsible for ensuring that the federation follows safe recruitment processes as outlined within the KCSIE and EYFS guidance.
 - The Governing Body will ensure that at least one of the persons who conducts an interview has completed safer recruitment training.
 - We will obtain an enhanced check by Disclosure and Barring Service (DBS) in respect of every person aged 16 and over (including volunteers) who work directly with children.
- To check and confirm the suitability of new employees, we will ensure that references are obtained before employment and:
 - Not accept open references e.g. to whom it may concern.
 - Not rely on applicants to obtain their reference.

- Ensure any references are from the applicant's current employer, training provider or education setting and have been completed by a senior person with appropriate authority.
- o Not accept references from a family member.
- Obtain verification of the individual's most recent relevant period of employment where the applicant is not currently employed.
- Secure a reference from the relevant employer from the last time the applicant worked with children. If the applicant has never worked with children, then we will ensure a reference is from their current employer, training provider or education setting.
- o Ensure electronic references originate from a legitimate source.
- Contact referees to clarify content where information is vague or insufficient information is provided.
- Compare the information on the application form with that in the reference and take up any discrepancies with the applicant.
- Establish the reason for the applicant leaving their current or most recent post, and ensure any concerns are resolved satisfactorily before appointment is confirmed.
- The Lightyear Federation maintains an accurate Single Central Record (SCR) in line with statutory guidance.
- The Lightyear Federation are committed to supporting the statutory guidance from the Department for Education on the application of the Childcare (Disqualification) Regulations 2009 and related obligations under the Childcare Act 2006 in schools.
- We advise all staff to disclose any reason that may affect their suitability to work with children including convictions, cautions, court orders, reprimands, and warnings.
- Where The Lightyear Federation places a learner with an alternative provision provider, we will:
 - obtain written information from the alternative provision provider that appropriate safeguarding checks have been carried out on individuals working at the establishment, i.e., those checks that our federation would otherwise perform in respect of our own staff.
 - obtain written confirmation that the alternative provider will inform the commissioning federation
 of any arrangements that may put the child at risk (i.e. staff changes), so that the
 commissioning federation can ensure itself that appropriate safeguarding checks have been
 carried out on new staff.

8.2 Allegations/concerns raised in relation to staff, including supply teachers, volunteers and contractors

- Any concerns or allegations about staff will be recorded and dealt with appropriately in line with Part
 four of KCSIE and the <u>local Kent allegations arrangements</u>, including discussions as necessary with
 the Local Authority Designated Officer (LADO). Ensuring concerns are dealt with effectively will protect
 those working in or on behalf of the federation from potential false allegations or misunderstandings.
- In depth information can be found within our 'Managing Allegations against Staff' and staff code of conduct policy. This can be found in the staff safeguarding file kept in each school staffroom.
- Where the Executive Headteacher/Head of School are unsure how to respond, for example if the federation is unsure if a concern meet the harm 'thresholds' (section 8.2.1), advice will be sought via the LADO Education Safeguarding Advisory Service enquiry form.
- After resolving or concluding allegations or low-level concerns about staff, the Executive
 Headteacher/Head of School, along with the <u>LADO</u>, if involved, will review the case to identify lessons
 learned and any possible improvements.

In the situation that The Lightyear Federation receives an allegation relating to an incident that
happened when an individual or organisation was using our premises for the purposes of running
activities for children (for example community groups, sports associations, or service providers that
run extra-curricular activities), we will follow our safeguarding policies and procedures, including
informing the LADO.

8.2.1 Concerns that meet the 'harm threshold'

- The Lightyear Federation recognises that it is possible for any member of staff, including volunteers, governors, contractors, agency and third-party staff (including supply teachers) and visitors to behave in a way that indicates a person would pose a risk of harm if they continue to work in their present position, or in any capacity with children in a school or nursery. This includes when someone has:
 - o behaved in a way that has harmed a child, or may have harmed a child
 - o possibly committed a criminal offence against or related to a child
 - behaved towards a child or children in a way that indicates he or she may pose a risk of harm to children
 - behaved or may have behaved in a way that indicates they may not be suitable to work with children.
- Allegations against staff which meet this threshold will be responded to and managed in line with Part Four of KCSIE. Allegations that meet the harm threshold will be referred immediately to the Head of School/Executive Headteacher who will follow the procedure in our 'Managing Allegations Against Staff Policy' to liaise with two other Designated Safeguarding Leads who will ensure compliance with this policy, local and national guidance, and agree any decision, before then contacting the <u>LADO</u> to agree further action to be taken in respect of the child and staff member. In the event of allegations of abuse being made against the Executive Headteacher, staff are advised that allegations should be reported to the Chair of Governors who will contact the LADO.
- If staff are concerned that appropriate safeguarding action is not being taken following an allegation against a colleague, they are advised to follow our whistleblowing process and/or to contact the LADO directly themselves.

8.2.2 Concerns that do not meet the 'harm threshold'

- The Lightyear Federation may also need to take action in response to 'low-level' concerns about staff.
 Additional information regarding low-level concerns is contained with our staff behaviour code of
 conduct this includes what a low-level concern is, the importance of sharing them and the
 confidential procedure to follow when sharing them.
 - The Lightyear Federation has an open and transparent culture in which all concerns about all adults working in or on behalf of the federation are dealt with promptly and appropriately; this enables us to identify inappropriate, problematic or concerning behaviour early, minimise the risk of abuse and ensure that adults working in or on behalf of the federation are clear about and act within appropriate professional boundaries, and in accordance with our ethos and values.
 - A 'low-level' concern does not mean that it is insignificant; a low-level concern is any concern that an adult working in or on behalf of the federation may have acted in a way that is inconsistent with our staff code of conduct, including inappropriate conduct outside of work and does not meet the 'harm threshold' or is otherwise not serious enough to consider a referral to the LADO.
 - Low-level concerns may arise in several ways and from a number of sources. For example, suspicion, complaints, or allegations made by a child, parent or other adult within or outside of the organisation, or as a result of vetting checks.

- It is crucial that all low-level concerns are shared responsibly, recorded and dealt with appropriately to protect staff from becoming the subject of potential false low-level concerns or misunderstandings.
- Low-level concerns should be shared confidentially in line with our code of conduct to the Executive Headteacher/Head of School.
 - Where low-level concerns are reported to the school/nursery, the Executive Headteacher/Head of School will be informed of all low level concerns and is the ultimate decision maker in respect of the response to all low-level concerns.
 - If appropriate, the Executive Headteacher/Head of School will share concerns and liaise with the LADO enquiries officer
 - Low-level concerns shared about supply staff and contractors will be shared with their employers so any potential patterns of inappropriate behaviour can be identified.
 - If the federation is in any doubt as to whether the information which has been shared about a member of staff as a low-level concern in fact meets the harm threshold, we will consult with the LADO.
- Low-level concerns will be recorded in writing and reviewed so potential patterns of concerning, problematic or inappropriate behaviour can be identified.
 - Records will be kept confidential and will be held securely and retained and in compliance with the Data Protection Act 2018 and the UK General Data Protection Regulation (UK GDPR) and other relevant policies and procedures (for example data retention policies).
 - Where a pattern is identified, the federation will implement appropriate action, for example consulting with <u>the LADO</u>. and following our disciplinary/HR procedures.

8.3 Safe Culture

- As part of our approach to safeguarding, The Lightyear Federation has created and embedded a
 culture of openness, trust and transparency in which our values and expected behaviour as set out in
 our staff code of conduct are constantly lived, monitored and reinforced by all staff (including supply
 teachers, volunteers and contractors) and where all concerns are dealt with promptly and
 appropriately.
- Staff are encouraged and should feel confident to self-refer, if they have found themselves in a
 situation which could be misinterpreted, might appear compromising to others, and/or on reflection
 they believe they have behaved in such a way that they consider falls below the expected professional
 standards. This includes where concerns may be felt to be deliberately invented or malicious; such
 allegations are extremely rare and as such all concerns should be reported and recorded.
- All staff and volunteers should feel able to raise any concerns about poor or unsafe practice and
 potential failures in the federation safeguarding regime. The leadership team within our federation will
 take all concerns or allegations received seriously.
- All members of staff are made aware of the federation Whistleblowing policy (available on the school
 website). It is a disciplinary offence not to report concerns about the conduct of a colleague that could
 place a child at risk.
- Staff can access the NSPCC whistleblowing helpline if they do not feel able to raise concerns regarding child protection failures internally. Staff can call 0800 028 0285 (8:00 AM to 8:00 PM Monday to Friday) or email help@nspcc.org.uk.
- The Lightyear Federation has a legal duty to refer to the Disclosure and Barring Service (DBS) anyone who has harmed, or poses a risk of harm, to a child, or if there is reason to believe the member of staff has committed one of a number of listed offences, and who has been removed from working (paid or

unpaid) in regulated activity or would have been removed had they not left. The DBS will consider whether to bar the person.

 If these circumstances arise in relation to a member of staff within our federation, a referral will be made as soon as possible after the resignation or removal of the individual in accordance with advice from the LADO.

9 Opportunities to Teach Safeguarding

- The Lightyear Federation will ensure that children are taught about safeguarding, including online safety, as part of providing a broad and balanced curriculum. This will include covering relevant issues through Relationships Education, online safety lessons and assemblies.
- We recognise that schools and nurseries play an essential role in helping children to understand and identify the parameters of what is appropriate child and adult behaviour, what is 'safe,' to recognise when they and others close to them are not safe, and how to seek advice and support when they are concerned. Our curriculum provides opportunities for increasing self-awareness, self-esteem, social and emotional understanding, assertiveness and decision making so that children have a range of age appropriate contacts and strategies to ensure their own protection and that of others.
- The Lightyear Federation recognises the crucial role we have to play in preventative education.
 Preventative education is most effective in the context of a whole-federation approach which prepares children for life in modern Britain and creates a culture of zero tolerance for sexism, misogyny/misandry, homophobia, biphobic and sexual violence/harassment.
- The Lightyear Federation has a clear set of values and standards, upheld and demonstrated throughout all aspects of school and nursery life which are underpinned by our behaviour policy and pastoral support system, as well as by a planned programme of evidence-based RSHE delivered in regularly timetabled lessons and reinforced throughout the whole curriculum. Our programme is fully inclusive and developed to be age and stage of development appropriate.
- The Lightyear Federation recognise that a one size fits all approach will not be appropriate for all
 children, and a more personalised or contextualised approach, tailored to the specific needs and
 vulnerabilities of individual children might be needed, for example children who are victims of abuse,
 neglect or exploitation, and children with SEND.
- The Lightyear Federation systems support children to talk to a range of staff. All children will be listened to and heard, and their concerns will always be taken seriously and acted upon as appropriate.
- The Lightyear Federation recognises the value of external organisations and/or speakers visiting to
 provide useful information or to help enrich children's education. However, our federation will always
 assess the suitability of external organisations or speakers before granting them access to learners;
 this may include an assessment of the educational value, the age/ability appropriateness of content
 and whether relevant safeguarding checks will be required.

10 Physical Safety

10.1 Use of 'reasonable force'

 There may be circumstances when it is appropriate for staff to use reasonable force in order to safeguard children from harm. The term 'reasonable force' covers the broad range of actions used by staff that involve a degree of physical contact to control or restrain children. This can range from guiding a child to safety by the arm, to more extreme circumstances such as breaking up a fight or where a child needs to be restrained to prevent violence or injury. 'Reasonable' in these circumstances means 'using no more force than is needed'. Further information regarding our approach and expectations can be found in our behaviour policy and physical intervention policy and in line with the DfE 'Use of reasonable force in schools' guidance.

10.2 The use of federation premises by other organisations

- Where our federation facilities or premises are rented/hired out to organisations or individuals (for example to community groups, sports associations, and service providers to run community or extracurricular activities) we will ensure that appropriate arrangements are in place to keep children safe.
 - Where those services or activities are provided under the direct supervision or management of our federation staff, our existing arrangements for child protection, including this policy, will apply.
 - Where services or activities are provided separately by another body using the federation facilities/premises, the Executive Headteacher/Head of School and governing body will seek assurance that the provider concerned has appropriate safeguarding and child protection policies and procedures in place (including inspecting these as needed); and ensure that there are arrangements in place for the provider to liaise with the federation on these matters where appropriate. If this assurance is not achieved, an application to use premises will be refused.
- Safeguarding requirements will be included in any transfer of control agreement (such as a lease or hire agreement), as a condition of use and occupation of the premises. Failure to comply with this will lead to termination of the agreement.

10.3 Site security

- All members of staff have a responsibility for maintaining awareness of buildings and grounds security
 and for reporting concerns that may come to light, including ensuring that gates are closed, door
 passes/codes are not shared and staff wear badges/lanyards etc.
- Our staffing arrangements will ensure that we are able to meet the needs of all children and ensure their safety.
- The Lightyear Federation will ensure that, with the exception of for those children who have parental consent to walk home alone, children are only released to the care of individuals of whom the parent has explicitly approved/agreed. Details of those with authorisation to collect are listed on Arbor.
- Appropriate checks will be undertaken in respect of visitors and volunteers coming into school /nursery
 as outlined within national guidance. Visitors will be expected to sign in and out via the office visitors
 log and to display a visitor's badge whilst on site. Visitors without an appropriate DBS will be
 escorted/supervised around site.
- For visitors attending in a professional capacity, such as social workers and early help staff, the school
 office will check their ID and be assured that they have has had the appropriate DBS check or their
 employers have confirmed that their staff have appropriate checks.
- Any individual who is not known or identifiable on site should be challenged for clarification and reassurance.
- The Lightyear Federation will not accept the behaviour of any individual (parent or other) that threatens school/nursery security or leads others (child or adult) to feel unsafe. Such behaviour will be

treated as a serious concern and may result in a decision to refuse access for that individual to the school/nursery site.

10.4 Safer eating for EYFS children

- The Lightyear Federation will ensure that there will always be a member of staff in the room with a valid paediatric first aid certificate when EYFS children are eating.
- Before a child is admitted to the school or nursery setting, we will obtain information about any
 special dietary requirements, preferences, food allergies and intolerances that the child has, and
 any special health requirements.
 - This information will be shared with all staff involved in the preparation and handling of food
 - At each mealtime and snack time there will be a clear statement about who is responsible for checking that the food being provided meets all the requirements for each child.
 - The Lightyear Federation will have ongoing discussions with parents/carers and, where appropriate, health professionals to develop allergy action plans for managing any known allergies and intolerances. This information will be kept up to date and shared with all staff.
- The Lightyear Federation will have ongoing discussions with parents/carers about the stage their child is at in regard to introducing solid foods, including understanding the textures the child is familiar with.
 - Assumptions will not be made based on age.
 - The setting will prepare food in a suitable way for each child's individual developmental needs, working with parents/carers to help children move on to the next stage at a pace that is right for the child.
- The Lightyear Federation will prepare and manage food in a way to prevent choking.
 - Young children will be seated safely in an appropriately sized low chair while eating.
 - Where possible there will be a designated eating space where distractions are minimised.
 Lunches will be eaten in the Main Hall.
 - Children will always be within sight and hearing of a member of staff whilst eating. Choking can be completely silent therefore it is important for staff to be alert to when a child may be starting to choke. Where possible, staff will sit facing children whilst they eat so they can make sure children are eating in a way to prevent choking and so they can prevent food sharing and be aware of any unexpected allergic reactions.
- When a child experiences a choking incident that requires intervention, The Lightyear Federation will record details of where and how the child choked and parents/carers will be made aware.
- Records will be reviewed regularly to identify if there are trends or common features of incidents that
 could be addressed to reduce the risk of choking, and the leadership team will ensure appropriate
 action is taken to address any identified concerns.

Appendix 1: Categories of Abuse

All staff should be aware that abuse, neglect, exploitation and other safeguarding issues are rarely standalone events that can be covered by one definition or label. In most cases multiple issues will overlap with one another.

Abuse: a form of maltreatment of a child. Somebody may abuse or neglect a child by inflicting harm, or by failing to act to prevent harm. Abuse can be carried out both on and offline and be perpetrated by men, women, and children.

Sexual abuse: involves forcing or enticing a child or young person to take part in sexual activities, not necessarily involving a high level of violence, whether or not the child is aware of what is happening. The activities may involve physical contact, including assault by penetration (for example rape or oral sex) or non-penetrative acts such as masturbation, kissing, rubbing, and touching outside of clothing. They may also include non-contact activities, such as involving children in looking at, or in the production of, sexual images, watching sexual activities, encouraging children to behave in sexually inappropriate ways, or grooming a child in preparation for abuse (including via the internet). Sexual abuse is not solely perpetrated by adult males. Women can also commit acts of sexual abuse, as can other children.

Signs that MAY INDICATE Sexual Abuse

- Sudden changes in behaviour and performance
- Displays of affection which are sexual and age inappropriate
- Self-harm, self-mutilation or attempts at suicide
- Alluding to secrets which they cannot reveal
- Tendency to cling or need constant reassurance
- Regression to younger behaviour for example thumb sucking, playing with discarded toys, acting like a baby
- Distrust of familiar adults, for example, anxiety of being left with relatives, a childminder or lodger
- Unexplained gifts or money
- Depression and withdrawal
- Fear of undressing for PE
- Sexually transmitted disease
- Fire setting

The <u>Centre of Expertise on Child Sexual Abuse</u> provides resources to help education professionals identify and respond to concerns of child sexual abuse and abusive behaviours.

Physical abuse: a form of abuse which may involve hitting, shaking, throwing, poisoning, burning, or scalding, drowning, suffocating or otherwise causing physical harm to a child. Physical harm may also be caused when a parent or carer fabricates the symptoms of, or deliberately induces, illness in a child.

Signs that MAY INDICATE physical abuse

- Bruises and abrasions around the face
- Damage or injury around the mouth
- Bi-lateral injuries such as two bruised eyes
- Bruising to soft area of the face such as the cheeks
- Fingertip bruising to the front or back of torso
- Bite marks
- Burns or scalds (unusual patterns and spread of injuries)
- Deep contact burns such as cigarette burns
- Injuries suggesting beatings (strap marks, welts)
- Covering arms and legs even when hot
- Aggressive behaviour or severe temper outbursts.

Injuries need to be accounted for. Inadequate, inconsistent, or excessively plausible explanations
or a delay in seeking treatment should signal concern.

Emotional abuse: the persistent emotional maltreatment of a child such as to cause severe and adverse effects on the child's emotional development. It may involve conveying to a child that they are worthless or unloved, inadequate, or valued only insofar as they meet the needs of another person. It may include not giving the child opportunities to express their views, deliberately silencing them or 'making fun' of what they say or how they communicate. It may feature age or developmentally inappropriate expectations being imposed on children. These may include interactions that are beyond a child's developmental capability as well as overprotection and limitation of exploration and learning or preventing the child participating in normal social interaction. It may involve seeing or hearing the ill-treatment of another. It may involve serious bullying (including cyberbullying), causing children frequently to feel frightened or in danger, or the exploitation or corruption of children. Some level of emotional abuse is involved in all types of maltreatment of a child, although it may occur alone.

Signs that MAY INDICATE emotional abuse

- Over reaction to mistakes
- Lack of self-confidence/esteem
- Sudden speech disorders
- Self-harming
- Eating Disorders
- Extremes of passivity and/or aggression
- Compulsive stealing
- Drug, alcohol, solvent abuse
- Fear of parents being contacted
- Unwillingness or inability to play
- Excessive need for approval, attention, and affection

Neglect: the persistent failure to meet a child's basic physical and/or psychological needs, likely to result in the serious impairment of the child's health or development. Neglect may occur during pregnancy as a result of maternal substance abuse. Once a child is born, neglect may involve a parent or carer failing to: provide adequate food, clothing, and shelter (including exclusion from home or abandonment); protect a child from physical and emotional harm or danger; ensure adequate supervision (including the use of inadequate care-givers); or ensure access to appropriate medical care or treatment. It may also include neglect of, or unresponsiveness to, a child's basic emotional needs.

Signs that MAY INDICATE neglect.

- Constant hunger
- Poor personal hygiene
- Constant tiredness
- Inadequate clothing
- Frequent lateness or non-attendance
- Untreated medical problems
- Poor relationship with peers
- Compulsive stealing and scavenging
- Rocking, hair twisting and thumb sucking
- Running away
- Loss of weight or being constantly underweight
- Low self esteem
