



Consultation on a federation of

Greatstone Primary School

&

Repton Manor Primary School

Consultation period:

Wednesday 20th April 2022 to Wednesday 8th June 2022

What is this information and consultation about?

Greatstone Primary School and Repton Manor Primary School are two unique Foundation schools in different communities. Over the last year, the schools have been working effectively together.

The Governing Bodies of both schools have agreed to consult with staff, parents, guardians and other interested parties on a proposal to form a working partnership and become a federation. The governing bodies see this as an opportunity to formalise the way the schools are working together and to secure good and effective leadership across both schools to maintain and improve standards. A federation is an arrangement that formalises the way that two schools will work together.

A federation is a partnership of two schools sharing a governing body whilst each school retains its own independence and identity. It is not a merger of the two schools. Therefore:

- the names of the schools will not change.
- the uniforms will stay the same.
- the admissions arrangements will not change.

This is good for pupils and parents as:

- the schools will each continue to have the same ethos as they have today.
- The children will be able to access opportunities that they could not as two individual schools.
- the two schools serve different communities, each can learn from the other and benefit from working together.
- the sharing of expert staff knowledge and experience will enrich the opportunities for pupils.
- Staff will have the opportunity to make use of resources from both schools to best meet the needs of the children.

This is good for staff as:

- they will be able to share knowledge and expertise with colleagues across both schools.
- they will have new opportunities for professional development.
- there will be consistent and strengthened leadership across both schools.
- there will be opportunities for staff to extend their leadership and management skills and enhance their career development opportunities.

What changes will the pupils, parents, staff and governors see?

The pupils will have access to more opportunities for good quality learning. There will be opportunities to use school resources and budgets more efficiently. The two schools are different, however the governing bodies recognise that a federation will enable each school to learn from the other, whilst remaining independent, to the benefit of both sets of pupils.

The staff will have increased opportunities to collaborate and learn from each other. There will be greater opportunities for career development. There will be an Executive Headteacher overseeing one Head of School and one Deputy Headteacher at each school. Staff will continue to share their specialist knowledge with the other school, so that the schools can extend best practice.

The parents will see increased opportunities for learning as resources can be accessed across both schools. Collaboration of staff across both schools will support children to overcome barriers to learning.

One Federated Governing Body will be created to oversee the co-ordinated working and the governors will have the opportunity to formulate policy and overarching strategy to ensure consistent practice across both schools. The governors will be able to support alongside the senior leadership, the increased opportunities for pupil learning and staff development from which both schools will benefit as part of the Federation. As foundation schools, the federated governing body would continue to be the admissions authority.

The Federation Governing Body would have members drawn from both current governing bodies and schools. It is the intention that there will be two Committees, one for each school, to provide governance at a local school level; these will ensure that each school retains its own unique identity in its particular community and environment.

As this will be a new governing body, elections will need to be held for parent and staff governors.

The proposed membership for the federation governing body would consist of 19 Governors as follows:

The Executive Head Teacher 2 Elected parent governors 1 Elected staff governor 2 Partnership governors 1 Local Authority governor Up to 12 co-opted governors which will include 1 co-opted staff governor In addition, the federated governing body would be able to appoint associat

In addition, the federated governing body would be able to appoint associate members to each local school committee. These would be members whom, in the opinion of the federation governing body, would contribute to maintaining the individual character of each school. Each committee would include the local Head of School.

If the proposal is agreed, the federation will begin on 01 July 2022.

Will the funding arrangements change?

Each school will retain its own budget. The Federation Governing Body will have oversite of how funds can be deployed to maximise the benefits of federation while meeting the needs of each individual school.
